#### I. Call to Order

Meeting was called to order by Mr. Schoech at 11:30am.

#### II. Approval of February Minutes

A motion was made by Dr. Templeton to approve minutes, Mr. Baker seconded. Motion carried.

#### III. Overdose Risk Score

Appriss Health provides an Overdose risk Score for each patient in K-TRACS. In a recent presentation at the Rx Summit, Brad Bauer noted that only 1% of the population had an overdose risk score of over 650. The Committee was interested in learning where the rest of the population scores ranked. Per Appriss the break down is:

010 – 200: 75% of the population

201 – 650: 24% of the population

> 650: 1% of the population

#### IV. K-TRACS Funding and Legislative Updates

Ms. Blasi provided the Advisory Committee with an update regarding legislative items and a K-TRACS funding update.

Currently K-TRACS has solid funding through fiscal year 2021, which ends on July 1, 2021. Ms. Blasi and Ms. Donnelly will coordinate a meeting between the Board of Pharmacy staff, other fee funded agencies and other key stakeholders to discuss a more permanent K\_TRACS funding solution. Currently K-TRACS does receive funding from 2 federal grants and the K-TRACS staff have applied for additional funding due to start October 2020. It is anticipated we will hear if the application was successful in September 2020.

The Discussion: 2020 Legislative session was cut short due to COVID-19. It is not anticipated that any new legislation related to K-TRACS will be passed this in FY 2020. The legislation will be reintroduced in FY 2021.

Dr. Templeton moved the committee recess into executive session to:

- Review or discuss matters, including private health information, for the purpose of reviewing and analyzing K-TRACS data for the purpose of identifying patterns and activity of concern under the authority of KSA 75-4319(b)(5) and 65-1685(d) and will resume the open meeting at 12:30pm. The motion was seconded by Mr. Baker and the motion carried.

Mr. Baker moved that a letter be sent to providers as far back as September 2019 of potential drug seeking behavior. Mr. Coble seconded, motion carried.

Mr. Baker moved that no action be taken. Mr. Coble seconded, motion carried.
